Membership Fees

Please note that at the meeting of the Board of Directors on 30 March 2026, the Board took the decision to increase fees from 1 April 2026.

Membership fees contribute to covering the administrative costs of running the Chamber which include administrative, communication and advocacy services, corporate secretarial and compliance, members' annual and quarterly meetings, accounting, bank charges and membership in the European Business Organisations Worldwide Network (EBO WWN). **Special events and programmes are not covered but may be subsidised depending on the status of the accounts.**

For firms and professionals operating in Trinidad and Tobago:

- **TTD 1000 from April 1, 2026 for 1 company representative or 1 professional.**
- **TTD 2000 from April 1, 2026 for up to three company representatives.**

For firms and professionals based in Europe or in the region:

- **EURO 125 from April 1, 2026, for 1 company representative or 1 professional.**
- **EURO 250 from April 1, 2026, for up to three company representatives.**

The rates are reviewed by the directors from time to time and may be changed at the start of the new cycle depending on administrative costs.

Membership fees are due annually from April 1 of each year and are valid up to March 31st of the following year.
